Suspension or Expulsion

Membership in X9 is a privilege, not a right. The Organization acknowledges that its membership may be suspended or terminated by the Board of Directors if the Board determines that the Organization or any of its representatives has:

1. failed to comply with the Bylaws, procedures, or policies of X9; or
2. engaged in conduct contrary to the purposes or best interests of X9.

Any suspension or expulsion shall be imposed in accordance with the Bylaws and Procedures of X9 and may result in the loss of some or all membership rights and privileges.
